

## PRIVACY POLICY

This is the Privacy Policy of Trippz B.V. (hereinafter referred to as "**Trippz**", "we", "us" or "our"), a company with address Daalsesingel 51- O4.10 , 3511 SW, Utrecht. Trippz is registered with the Chamber of Commerce under number 78453925.

This Privacy Policy explains how we collect, use, share and protect data in relation to our website/application trippz.app (the "**Website**"). We collect this data when you visit our Website using your computer, tablet or cell phone ("**Computer**"). We process personal data in a manner consistent with the General Data Protection Regulation (the "**AVG**"), implementing legislation based on the AVG and other currently applicable privacy legislation.

By using our Website, you understand and agree to the collection and use of information in accordance with this Privacy Policy. Our Privacy Policy applies to all visitors, users and all others who have access to the Website ("**Users**").

### What information do we collect?

We collect the following information that you provide to us:

- a. User name, password and email address when you register for a Trippz account
- b. Profile information you provide through your account
- c. Communications between Trippz and you (we may send you service-related emails)

### Log File Information

We only collect information that your browser sends when you visit our Website when it is necessary for the proper functioning of the Website. In particular, by the proper functioning of the Website, we mean protecting the Website from actions that could compromise the security of the Website and your Computer. This log file may contain information such as your IP address, browser type, browser version, the pages of our Website that you visit, the time and date of your visit, the time you spend on these pages and other statistics.

### Analytical Services

We use third-party analytical services. These help us measure our traffic and trends of the Website. The tools collect information sent by your Computer, our Website, the web pages you visit, add-ons and by other information that helps us improve our Website. These tools use "cookies. These are simple text files that are stored on your hard drive or in your Computer's memory. Cookies cannot damage your Computer or the files stored on your Computer.

Cookies collect information anonymously about your login information and login behaviour. We use this information with information from other Users. This makes it

impossible for us to identify you as an individual. We use Google Analytics for our analytical services. Google Analytics installs a permanent cookie in your web browser to identify you. This means that your data is shared with Google. We only share data with Google that we are permitted to share under the AVG. You can completely prevent Google Analytics from recognising you by deactivating the cookies in your browser.

### **How do we use this information?**

We use all the information we collect to support and improve our Website.

### **How is this information shared?**

We will not rent or sell your (personal) data to third parties.

### **Change of Control**

If Trippz, or any part of it, is sold, transferred, or one of our assets goes to another organization (for example, as a result of a merger, acquisition, bankruptcy, dissolution, or liquidation), then data collected through the Website may be included in the sold or transferred assets. The buyer or transferee will need to follow the agreements in this Privacy Policy.

### **Legal request and prevention of damage**

Pursuant to a legal request, we are entitled to access, retain and/or share your information in response to a legal request (such as a search warrant, court order or subpoena). We are also entitled to retain and/or share your information when we believe it is necessary to detect, prevent and raise concerns about fraud or other illegal activity and to protect us, you and others. Information we receive about you may be accessed, edited and retained for an extended period when necessary due to a legal request or obligation, an investigation regarding our terms, policies or to otherwise prevent harm.

### **Security and Safety**

Trippz has taken appropriate technical and organizational measures to secure your data against loss or any form of unlawful processing. We use security measures to ensure that information through the Website is protected (such as requesting a unique password). However, Trippz cannot ensure that information on the Website will not be accessed, disclosed, altered or destroyed. You are responsible at all times for maintaining your unique password and account information and for managing the emails between you and Trippz. We are not responsible for the functionality, privacy or security measures of any other organization.

### **International transfer**

Your information may be transferred and maintained on computers and/or servers located outside the Netherlands and/or the EU, where data protection laws may differ. We make every effort to ensure that even when your personal data is processed outside the EU, it is processed outside the EU in a legally accurate and careful manner.

### **Retention period**

In accordance with the AVG and other relevant legislation, Trippz does not retain personal data for longer than is necessary for the purposes for which they are collected or processed.
